## Central Texas TeleCommunications College Scholarship Program 2018

Central Texas TeleCommunications offers a college scholarship program to assist graduating high school seniors who desire to further their education. Applications may be requested beginning January 31<sup>st</sup> of each year.

### **Amount and Disbursement of Scholarships**

A scholarship of \$750 will be awarded to two qualifying students of each school district in the telephone exchanges of Central Texas TeleCommunications. Scholarship funds will not be disbursed if there is not a qualifying student within a particular district. The full amount of the scholarship will be paid directly to the post-secondary educational institution upon receipt of proof of enrollment for a minimum of 12 hours, or full time status. Proof of enrollment must be provided by July 1<sup>st</sup> for the Fall Semester or December 1<sup>st</sup> for the Spring Semester in order to be processed and received by the school prior to the beginning of the semester. If the student does not attend the Fall Semester, the scholarship will be paid during the Spring Semester. Scholarship funds that remain unclaimed by a student within 12 months of the award date will be forfeited.

### **Type and Location of School**

The \$750 scholarship can be used for any educational institution of higher learning. This will include any junior college, college, university, technical, trade or vocational school.

### **Qualification Criteria**

The recipient must be a high school senior who is the dependent, and resides in the home, of an active member of Central Texas TeleCommunications. An active member is defined as a subscriber in good standing, receiving local **wireline telephone service** within a Central Texas TeleCommunications telephone exchange as of January 1, 2018. A member's wireline telephone number must begin with 239, 243, 286, 344, 372, 452, 463, 469, 471, 483, 622, 623, 628, 938, 948, 966 or 985. Dependents of Employees or Directors of Central Texas TeleCommunications or its affiliate companies are not eligible to apply.

### **Scholarship Application**

Completed scholarship applications must be submitted to Central Texas TeleCommunications, Attn: Scholarship Committee, PO Box 627, 1012 Reilley Street, Goldthwaite, TX, on or before March 31, 2018. Scholarship information and applications are available from the Central Texas TeleCommunications Business Office in Goldthwaite or by calling (325) 648-2237. Applications are also available for download on our web site at [centex.net](http://centex.net).

### **Scholarship Announcements**

Scholarship recipients will be announced at the High School Awards Ceremony, Graduation Ceremony, or other event as determined by the local school district of the selected recipients.

### **Statement of Nondiscrimination**

## SCHOLARSHIP APPLICATION REQUIREMENTS

- ✓ Applicant must be a high school senior and dependent residing in the home of an active member receiving service from Central Texas TeleCommunications. An active member is defined as a subscriber in good standing, receiving local wireline telephone service from a telephone exchange of Central Texas TeleCommunications as of **January 1, 2018.**
- ✓ Within 12 months of the award date, recipient must use scholarship to attend an accredited junior college, college, university, technical, trade or vocational school on a full time basis, or a minimum of 12 hours.
- ✓ Applicant must have a seven semester cumulative grade point average of **2.5 or equivalent on a 4.0 scale** for the 9<sup>th</sup>-12<sup>th</sup> grade.
- ✓ Applicant must submit a
  - Completed Application and Certification
  - Official High School Transcript, and College Transcripts if applicable
  - School Certification
  - 400-600 Word Essay
  - Educator's Recommendation
  - Letter of Recommendation (from a non-educator)
- ✓ Please note: Recommendation Letter from Educator, Recommendation Letter from Non-Educator, and School Certification **must be mailed or e-mailed directly** to Central Texas TeleCommunications.
- ✓ Essay Requirements: In a 400-600 word essay, describe **“Why Central Texas TeleCommunications Should Invest In My Education”**.
- ✓ **Incomplete or late applications will not be considered.**
